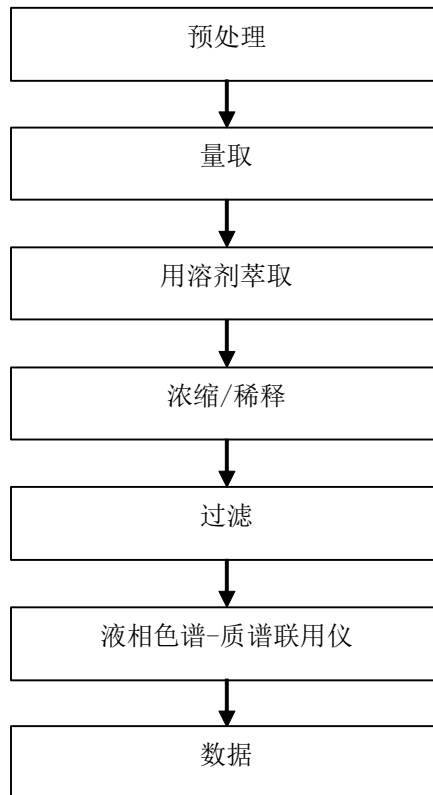

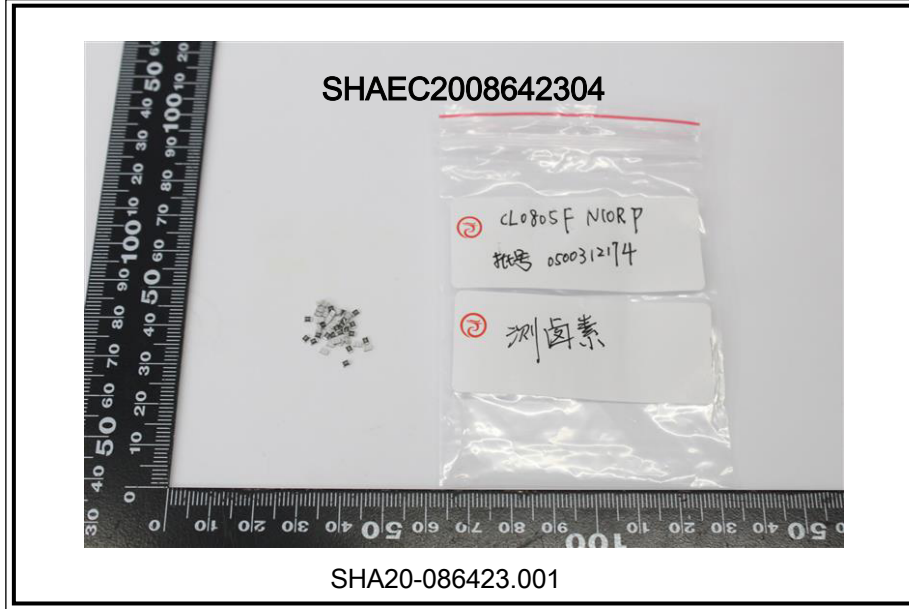
PFOS/PFOA 测试流程图
